
Business in Russia

Students acquire modern competences in building and developing business companies based on the in-depth knowledge of the relevant legal and tax administration framework, financial support methods in the presence of growing business risks, and qualitative changes in the commodity markets and international markets.

HIGHER SCHOOL OF PUBLIC ADMINISTRATION

Public Administration and Municipal Management

The advanced training course is focused on examining the concept, fundamentals of the modern public administration and municipal management, its structure, terms of reference, methodology and techniques used to exert influence.

Public Finance

The students of the program examine the legal regulation of operations of government institutions of all types. Special attention is paid to the specific characteristics of the municipal level financial system, incl. revenues gained by the publicly-funded institutions from funds allocated for operations performed in accordance with the government orders, funds allocated for other purposes, investment of budgetary funds, revenues from revenue-generating operations; engagement of commercial organizations in the public service rendering process.

Government Institutions' Finance Management

The course describes the financial support system that supports various types of government institutions, legal regulation of their operations, public procurement system, work performance, service rendering procedure used in public institutions, internal financial control and external audit system, the way accounting operations are performed and financial statements are compiled and submitted.

Public Financial Control

The students examine the theoretical and legal basis of financial control, the structure and powers of the auditing authorities, the arrangement of monitoring operations and methodology of monitoring, financial control methodology use (risk management, performance audit, etc.), supervision of the operations performed in accordance with the government orders, monitoring of the public procurement process, performance of works, service rendering process in the government institutions, reporting procedure, and liability for violating the financial law.

Internal Audit and Control in Government Institutions

The students examine the legal framework for the internal financial control system and internal financial audit system operations, supervision and monitoring methodology, key ways to improve internal financial control and internal financial audit efficiency in the public administration sector, liability for violating the financial law, etc.

Business Operation Management

The course is aimed at upgrading students' skills in corporate transport fleet management; office supplies, goods, equipment and service distribution, operations and strategic management of the business administration process, document support, corporate event management and business trip arrangement.

Business Operations in the Real Property Management Sector

The students examine the modern business administration methods used in the real property management sector. This includes immovable property selection, property lease for business purposes, office space finishing, building, construction and installation procedure, acceptance of work; office space management, office space maintenance and supplies distribution.



The students examine the fundamentals of personnel management strategy development and implementation, corporate HR policy, the foundations of strategic personnel management, formation and use of the HR and corporate intellectual capital, the potential of individual workers, intellectual property management and acquire the ability to apply the knowledge to practice.





INTERNATIONAL SCHOOL OF BUSINESS

Business Operations Analysis and Business Valuation

It is a practice-oriented program. It is based on the best business and business valuation case studies. The course includes 4 modules. They include the following main elements of corporate financial management: modern company financial statements analysis for managerial decision-making purposes; operations efficiency, break-even point, costs, working capital, risks and results; business valuation and company cost management; investment management and investment project efficiency assessment.

Lending Institution Financial Sustainability Assessment and Management

The course is based on case studies. Lending institutions' operations efficiency assessment methods are examined and financial sustainability analysis is conducted. The course describes the key requirements set by the megaregulator for the lending institutions to meet.

Lending Institution Asset and Liability Management

It is practice-oriented program. It is based on the best international practices in bank management for managerial decision-making purposes.

The course includes examination of relevant examples of risk management and a training in managerial decision-making aimed at managing the bank's balance sheet and profitability in an unstable macroeconomic environment.

The students acquire the ability to examine the position of a bank in the market and adjust it while taking into account the chosen operational strategy.

Legal Framework for Business Operations

The course is based on case studies. Lending institutions' operations efficiency assessment methods are examined and financial sustainability analysis is conducted. The course describes the key requirements set by the megaregulator for the lending institutions to meet.

INSTITUTE FOR PROFESSIONAL UPGRADE AND ADVANCED TRAINING PROGRAMS

Commercial Use of Intellectual Work Products

This advanced training course is focused on examining new Russian intellectual property protection laws; basic intellectual property management principles; conditions for, forms of intellectual work product commercial use; ways to make ideas, innovations, inventions and patents to be used commercially; technology used to develop, promote and sell intellectual work products; practical issues in the Russian Federal Service for Intellectual Property license agreement registration; protection of intellectual property rights and a review of legal practice.

Business Protocol and Etiquette for Civil Servants and Businessmen

The course includes the following:

- Protocol: diplomatic, international, state, business, corporate. Protocol seniority. State heraldic symbols and corporate paraphernalia.
- Protocol and business events: visits, negotiations, meetings, congresses, receptions. Characteristics of protocol measures.
 Essential elements of protocol in the government institutions and commercial companies.
- Culture and ethics, protocol and etiquette and employees' behavior (government institutions and commercial companies)

Taxes and Taxation: Regional Specifics, including the Russian Free Economic Zones

The students will learn the basic concepts and the meaning of the tax system of the Russian Federation, tax policy of the Russian Federation, direct and indirect taxes, regional taxation system, tax administration system. The students will also examine the special status and tax regime of the free economic zones in the Russian Federation.

E-Records Management and E-Archives of Financial Organizations

The students will examine information technology used in records management, accounting methodology, electronic document descriptions, their pre-storage processing, the fundamentals of electronic document security, their storage standards, Russian information security requirements, modern principles and methods used to manage electronic records and electronic archives in order to improve the quality of company operations.

Accounting

The students learn about the accounting methodology used in the epoch of modern computer systems and acquire practical skills in basic accounting using 1C: Enterprise software package. This is a full-fledged course in accounting. We start from scratch and go all the way to the balance sheet examination and examine the theoretical and practical issues. The students acquire skills in performing the accounting procedure and accounting transaction modelling, which leads to making better progress in the course of accounting studies.

Management Accounting and Budgeting

The students will learn how to examine various types of costs and assess the way they make an impact upon the financial results, to develop a corporate budget; will learn about the key types of budgets and financial statements, compile various budget data (cashflow budget, revenue and expenditure budget, balance sheet budget). The course is based on the modern best practices in managerial accounting system use. Practical skills are used when examples are examined using Microsoft Excel system.

Business Company Chief Accountant

The course is aimed at training students who want to take an examination and obtain a certificate of a business company chief accountant. The certificate is a proof of the accountant's professional qualifications and competences in the field; it certifies the ability to perform well in entities with various forms of ownership operating in various sectors, the certificate holders have a right to and can work as accounting and financial management consultants.

Government Institution Chief Accountant

The course is aimed at training students who want to take an examination and obtain a certificate of a government institution chief accountant.

The certificate is a proof of the accountant's professional qualifications and competences in the field; it certifies the ability to perform well in entities with various forms of ownership operating in various sectors, the certificate holders have a right to and can work as accounting and financial management consultants.

Procurement in Russia: a Methodology and Commercial Practice

The course includes the following 5 modules: general procurement methodology; procurement in government institutions and commercial organizations; special characteristics of procurement in government institutions and commercial organizations; participation in the procurement process arranged by government institutions and commercial organizations; procurement system development strategy in Russia. Topics that are of interest to both suppliers and contractors are examined.

International Financial Reporting Standards. A complete course

The students obtain in-depth theoretical and practical knowledge of the IFRS use and get trained in order to take examinations and obtain the Diploma for International Financial Reporting Standards DipIFR (ACCA) and DipIFRS (IFA).

Financial Director

The following topics are included into the course: professional values and ethics; legal regulation of economic operations; financial management; taxation; managerial accounting and budgeting; accounting; basics of audit; information and legal reference systems; International Financial Reporting Standards.

Internal Audit and Control

The students learn about the principles, methods, characteristics of the internal audit and control system within the corporate management system built in accordance with the legal and practical requirements. The course includes the following: professional values and ethics; legal regulation of economic operations; taxation; managerial accounting; basics of audit; International Financial Reporting Standards (IFRS); information and legal reference systems; internal audit and control; accounting and reporting.

Tax Consulting

The course helps students improve their competences related to tax, civil, accounting law, examine topical issues, practical taxation and tax consulting examples, examine the main trends of legal, arbitration practice associated with taxation. The course includes the following topics: tax law; taxation of legal and physical entities; legal regulation of economic operations; accounting and reporting; financial and economic analysis for tax consulting purposes; tax consulting methodology.

Public-Private Partnership Project Management in the Russian Regions

The course taught by the practitioners who have experience in developing in implementing PPP projects in Russia and abroad helps students acquire a wide theoretical knowledge and practical skills. CEOs and experts from the key departments of Avtodor Russian Highways, Vnesheconombank, federal and regional executive bodies, banks, legal firms, consulting companies and other companies are engaged in developing learning materials and master classes. A site-based program at the facilities built within the framework of the PPP project is organized in partnership with Avtodor.



INNOVATIVE LANGUAGE STRATEGY CENTER

Specialized Interpreter/ Translator further education program

BEC Vantage

BEC Higher (Business English Certificate Higher) is an examination developed by the University of Cambridge. This is a third level (post-advanced level) examination. The certificate is a proof of the ability to use the English language with confidence in a business environment, communicate freely in English in a professional environment and conduct negotiations. Upon completing the course, the students can do complex assignments and use the language for business and professional purposes (Level C1 in CEFR).

GMAT Examination Preparation

BEC Vantage (Business English Certificate Vantage) is a second (Upper-Intermediate) level examination. The students should be able to use the English language in day-to-day communication in a business environment, communicate in the workplace and communicate with the visitors. The examination is divided into 4 parts: oral speech, written speech, listening comprehension, and reading. Upon completing the course, the students can do assignments of average complexity and use the language for business and professional purposes (Level B2 in CEFR).

IELTS Examination Preparation

IELTS is a standardized test of English language proficiency. It is accepted by overseas higher education institutors and is necessary for the applicants to obtain an international certificate needed to become enrolled to Russian universities' master programs. IELTS tests the ability to listen, read, write and speak in English. Upon completing the course, the students can communicate in standard situations in an academic environment, use the English language when speaking in public.

HSK (Hanyu Shuiping Kaoshi) Examination Preparation

HSK is a test administered by Hanban, an agency of the Ministry of Education of the People's Republic of China, in cooperation with linguists, psychologists, and experts in instructor activity tracking. The test of Standard Chinese language proficiency for non-native speakers (international students and overseas Chinese) is used to check the skills in using Chinese in an academic, professional environment and everyday life.


Second Foreign Language (Russian)

TAX POLICY AND TAX ADMINISTRATION EDUCATIONAL AND RESEARCH CENTER

Modern International Tax Planning Architecture

The students examine corporate tax risks mitigation based on the use of modern international tax risk management methods and techniques; forecasts of the economic, financial and tax process development on the micro-, meso- and macrolevels based on the application of tax consulting methods to international taxation; modern tax administration technology used in international transactions.

Upon completing the course, the students will have basic theoretical knowledge of international taxation, will be able to use a systemic approach to examining characteristics of taxation systems in foreign countries; will have a systemic knowledge of transparency issues and tax information exchange.

Tax Collection Mechanisms and E-Commerce in the Epoch of Digitalization

The students of the program will have knowledge of the theoretical basis and legal framework for taxation operations in the electronic commerce sector; e-commerce market characteristics and development trends, basic e-commerce models, typical stages of an Internet business company formation; types, forms and methods of electronic commerce tax payment optimization; modern tax administration technologies used in electronic commerce sector; and acquire practical skills in making managerial decisions related to e-commerce development, will know modern trends and will be able to use e-commerce taxation tools and techniques.


Transport Logistics Management
